12:45 - 13:45 | Session 4: Workshop – From Policy to Courtroom: Litigating Against Institutionalization in the EU (1h)

- Activity: Ines will explain how policy advocacy can lead to strategic litigation and in which cases this can be an important tool for Disabled People's Organisations (DPOs) that are not specialised in litigation. She will use the example of ENIL's long-term work on monitoring how the EU Structural Funds are used and misused by the EU Member States. This work culminated in a case at the European Court of Justice in Luxembourg, against the European Commission. The session will provide an opportunity for participants to consider how this applies to their work and other human rights violations against disabled people..

- Activity: This session looks at supports in justice processes for persons with
 disabilities who are victims of crime. Participants will gain information about the
 different categories of measures States must provide based on UN and EU law.
 The session will look in particular at the rights of women with disabilities and
 children with disabilities, and provide examples of the kinds of accommodations
 that persons with disabilities can ask for in legal proceedings.

16:00 - 17:00 | Session 6: Workshop: Bridging Knowledge and Advocacy: Human Rights in Participatory Research.

- Activity: In this session, we will talk about participatory research that places people with disabilities to take a leading role in deciding what to research and how to approach it. This methodology uses the Convention on the Rights of People with Disabilities as a framework for designing the research and as a basis for determining its overall aim. It acknowledges the value of experiential knowledge in identifying human rights violations and provides tools to connect this expertise with the wider research production, which can then inform policies and lawmaking. The session includes a short theoretical background information, real life examples and some time to discuss research topics and methods to shape the participation of experts by experience.
